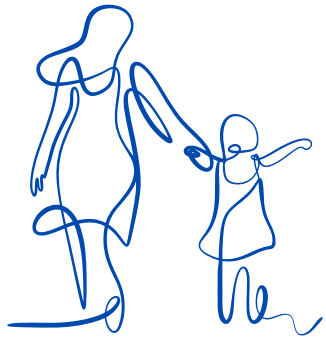

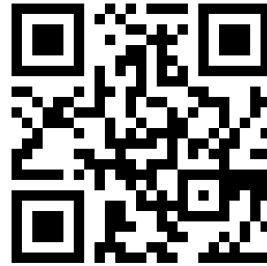

WHO ARE WE?

Right to Life of Central Kentucky is a 501c4, non-profit organization with headquarters located in Lexington, Kentucky. Our organization was incorporated in 1972 with the purpose to inform and educate the general public on questions relating to the sanctity of life. We are a chapter of Kentucky Right to Life (KRTL), the state affiliate to the National Right to Life Committee (NRLC).

We are privately funded by the generosity of our membership, event sponsors, and community donors. Membership is vital to our cause, as we rely heavily on volunteer service hours as well as financial contributions.

Did you know?

FACT #1

On June 24, 2022, *Dobbs vs. Jackson Women's Health Organization*, the Supreme Court overturned the 1973 decision known as *Roe vs. Wade*. Justice Samuel Alito, writing for the majority, held that "Roe was egregiously wrong from the start. Its reasoning was exceptionally weak, and the decision has had damaging consequences." Alito continued, "It is time to heed the Constitution and return the issue of abortion to the people's elected representatives."



FACT #2

The *Dobbs* decision overturned *Roe* but it did more – it negated the 1992 ruling in *Planned Parenthood of Southeastern Pa. v. Casey*. This decision went beyond *Roe* by making abortion a near absolute right, throughout the entire nine months of pregnancy.

Abortion-rights legal scholars had long held that while abortion should be legal, they admitted it was not the business of the courts to settle such matters. Alito noticed their admission, saying, "The Constitution makes no reference to abortion, and no such right is implicitly protected by any constitutional provision."

SUPPORT

Our chapter advocates and supports legislative bills covering all human life stages, from conception to natural death. FACT #3

In Kentucky, abortion remains illegal as it had been prior to the *Roe* decision, except in cases where an abortion was necessary to save the life of the mother.

Right to Life of Central Kentucky remains steadfast in its mission to preserve the human rights of all individuals from conception and birth, to the disabled, the infirmed, and up to natural death.
